

What Is the José Martí Scholarship?

Need- and Merit-Based

• Combines financial need and academic performance.

Award Amount

• Up to **\$2,000 per year**.

Who Can Apply

- High school seniors
- Undergraduate students
- Graduate students

Where It's Used

For students attending public or private colleges in Florida.

Who's It For

• Students of **Hispanic origin** with ties to **Mexico, Central/South America, or the Caribbean**. (Excludes Brazil, Spain, Haiti)

Why This Scholarship Matters

- •Named after José Martí, Cuban writer & educator
- Supports equal access to education for Hispanic students
- Honors a legacy of freedom, justice, and learning
- •"The best way to be free is to be educated." José Martí

Eligibility Checklist for Jose Marti Scholarship

Do You Qualify?

- Hispanic origin (see eligible countries)
- ✓ Florida resident
- U.S. citizen or eligible non-citizen
- GPA of 3.0 or higher
- Full-time student (12 credits undergrad / 9 grad)
- Financial need (Submit FAFSA)
- Not in default on state/federal aid

Important Dates

Mark These Dates for Jose Marti SCholarship!

Milestone	Date	Note
Application Opens	October 1, 2024	Start preparing documents early
FAFSA Submission Deadline	March 15, 2025	Required for financial need eligibility
Scholarship Application Deadline	April 1, 2025	No late applications accepted
Award Notifications	Summer 2025	Check your email and FSFA account

How to Apply in 6 Steps

- ✓ Submit FAFSA before March 15
- ✓ Create an account at Florida Student Financial Aid portal
- ✓ Select and complete the José Martí Scholarship form
- ✓ Upload transcripts (high school or college)
- ✓ Review all info carefully
- ✓ Submit by April 1, 2025

Pro Tips for a Strong Application

- Apply early spots may fill up
- Double-check transcript GPA
- Show clear proof of Hispanic origin
- Ask a school counsellor to review your application
- Stay enrolled full-time to remain eligible

Who Gets Selected First?

- Renewal applicants
- First-time high school seniors
- Reinstatement applicants
- Restoration applicants
- Graduate applicants

Frequently Asked Questions

Answer	
Yes, but they receive the lowest priority during the selection process.	
Yes, if you continue to meet all eligibility requirements.	
No essay is required for the state application, but some schools like FIU may request one separately.	
Yes, as long as it's an eligible private institution in Florida.	
A minimum cumulative GPA of 3.0 on a 4.0 scale is required.	
No. The scholarship is for students with origins in Hispanic countries (excluding Brazil, Spain, and Haiti).	
You may lose your eligibility for the scholarship. Full-time enrollment is required.
